

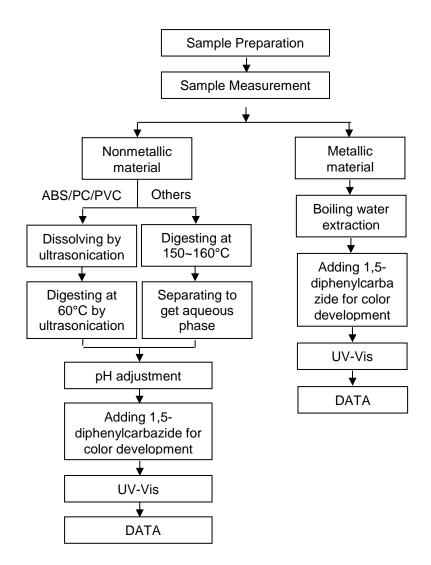

Hexavalent Chromium (Cr(VI)) Testing Flow Chart







### **PBB/PBDE/Phthalates Testing Flow Chart**








